Guidelines for NO VISA REQUIRED (NVR) SEAL

No Visa (NVR) Seal:

1. “No Visa Required” seal is applicable for Bangladesh-origin citizens of the Denmark, Iceland, Estonia and their family members (spouse and children)
2. Persons having NVR seals on their passports enjoy multiple entries into Bangladesh with no restriction on duration of stay within the validity of the passport.
3. For the children of Bangladesh nationals,
 - a. Child's Birth Certificate
 - b. Passport of the child(ren)'s father or mother having NVR seal
4. For spouses of foreign origin,
 - a. Notarized copy of the marriage certificate
 - b. Declaration of Bangladesh origin national on validity of marital status
 - c. Original copy of the passport along with its photocopy of Bangladesh origin national

Check list

- Filled-in application form, Photographs (Size: 37mmX37mm and recent one): 02 copies
- Bangladesh passport/ National ID/Birth certificate (17 digit)/Foreign old passport having NVR seal
- If name is changed during one's stay in a foreign country, legal document supporting the change or copy of court order
- Valid passport
- Payment for endorsing NVR seal has to be made only in Danish Krone (DKK) through **online bank transfer.**

- *Applicants intending to get his/her passport back before the date of delivery and without endorsement of NVR seal are requested to apply in writing on plain paper. No processing fee will be refunded.*

Submission: Consular hours for submitting the NVR applications are from **10.00 am to 12.00 pm** during work days. Passport are delivered the hours from **3.00 pm to 4.00 pm**. Three (03) working days are normally required for processing of NVR seal, provided all necessary papers are submitted.
